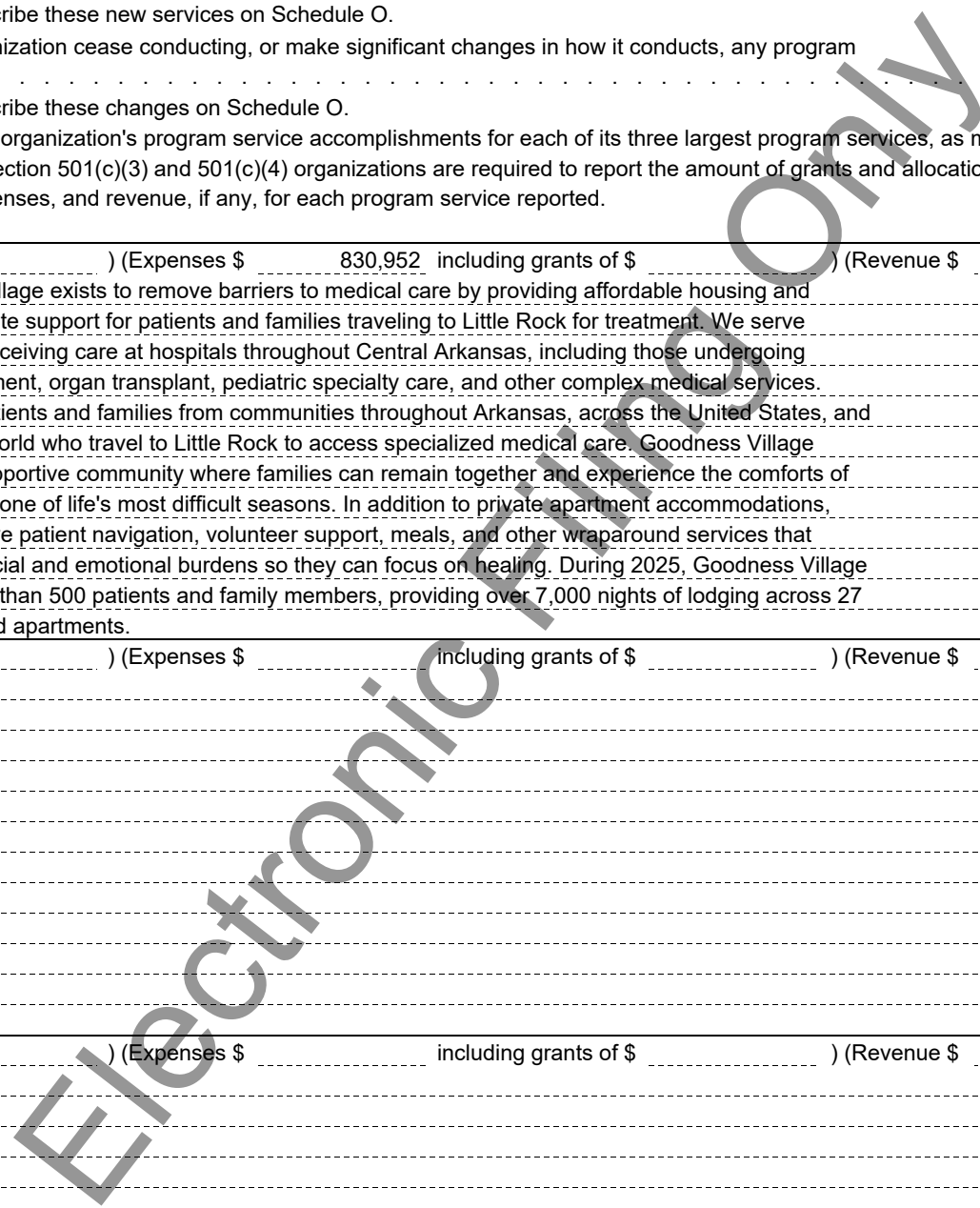

Goodness Village exists to remove barriers to medical care by providing affordable housing and compassionate support for patients and families traveling to Little Rock for treatment. We serve individuals receiving care at hospitals throughout Central Arkansas, including those undergoing cancer treatment, organ transplant, pediatric specialty care, and other complex medical services. We serve patients and families from communities throughout Arkansas, across the United States, and around the world who travel to Little Rock to access specialized medical care. Goodness Village creates a supportive community where families can remain together and experience the comforts of home during one of life's most difficult seasons. In addition to private apartment accommodations, guests receive patient navigation, volunteer support, meals, and other wraparound services that reduce financial and emotional burdens so they can focus on healing. During 2025, Goodness Village served more than 500 patients and family members, providing over 7,000 nights of lodging across 27 fully furnished apartments.
